IMEKO GENERAL DATA PROTECTION 2023



This is the IMEKO privacy policy. (Website - www.imeko.org, and domain hunmeko.org and imeko.fyi. Later as domains). It governs the privacy of its users who choose it.

The policy sets out the different areas concerned. It outlines the obligations & requirements of the users and the website owners. It also details how this website processes, stores and protects user data. Information will also be detailed within this policy.

Protecting your data: The IMEKO Confederation privacy statement

Protecting your privacy is very important to us. Our domains ensure that the necessary steps are taken to protect the privacy of its users throughout their visit. Our domains comply with the GDPR requirements for user privacy; you can contact the Secretariat about your personal information. We want transparency about the information we collect and use.

We sometimes need to collect information about you to provide our full range of services and benefits.

What data do we collect?

We collect your personal data when signing up for membership, newsletters, updates, or events to receive information. This personal data includes your name, email address, organisation address, and other contact details.

We may also combine this personal data with others we hold about you across the IMEKO Confederation. For example, attendance at our events and the different channels you use to interact with us.

As part of our services, we may ask you to participate in consultations, surveys, etc. We may keep copies of any communications between you and the Confederation.

How do we use your data?

We will process your data for several reasons. Processing is necessary for our legitimate business interests:

- delivering communications
- attracting new members
- collecting opinions
- managing events

When you have given us your consent, it includes all electronic communications, also changing your preferences by email. You can also ask for your preferences to be updated.

Transfer data outside IMEKO.

Sometimes, we may process your data outside the European Economic Area (EEA). Countries may not have laws that protect your data to the same extent as in EEA. We take all possible actions to ensure that your data is processed securely and is protected against unauthorised access, loss or destruction, unlawful processing, and any inconsistent processing with the purposes set out in this privacy notice.

How long will we keep your data?

We will keep your data for as long as you continue to be IMEKO-affiliated, and it is reasonably necessary afterwards to fulfil any legal requirements.

How do we protect your data?

We take the security of your personal information seriously. We have established suitable physical, electronic and managerial procedures to safeguard and secure our information to prevent unauthorised access or disclosure and unlawful or unauthorised processing and accidental loss, destruction or damage.

We take all reasonable steps to protect any personal information you submit via the domains or email. However, as our website is grouped to the internet, which is inherently insecure, we cannot guarantee that the information you supply will not be intercepted while transmitted. Accordingly, we have no responsibility or liability for the security of personal information transmitted via our website.

Our website may, from time to time, contain links to third-party websites. If you follow a link to any of these websites, please note that when visiting, their privacy policies apply. We do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data to these websites.

Who do we share your data with?

The IMEKO Confederation will not sell your information to any third party. We may share your information with third parties where we have a legal duty to do so or provide you with a service you have requested.

Individual control for registered users

Persons registered with the website control their data by their user's name and email address. This identification process is necessary to ensure the account is unique to the given email address. Registered users can add more information to their account or give trusted persons (Secretariat or IMEKO Information officer) to do so. Data added to the account remains in the database until it is deleted by the registered user or an entrusted person.

You have the following explicit rights under general data protection regulations:

- The right to be informed
- The right of access
- The right to rectification
- The right to erasure (also known as the 'right to be forgotten)
- The right to restrict processing
- The right to data portability
- The right to object
- Rights concerning automated decision-making and profiling
- The right to withdraw your consent to collecting, holding and processing your personal data at any time.

Communication, engagement, and actions taken through external social media platforms other than the IMEKO website are custom to the terms and conditions and the privacy policies held with each social media platform.
